MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING is made this 8th day of July 2024

The ITPB (Institut Teknologi Pendidikan dan Bisnis Qana'ah Sidenreng Rappang), located at Jalan Pelanduk No 6. Kota/Kabupaten. Kab. Sidenreng Rappang Prov. Sulawesi Selatan Indonesia, and Korucuk Mahallesi Üniversite Caddesi No:21 Rektörlük Binası 57000 – SİNOP, Türkiye hereby agree to this agreement under the following provisions:

1.0 The two parties will initiate and encourage the following activities:

- 1.1 Exchange of students for relevant academic programs;
- 1.2 Exchange of faculty members as visiting scholars for teaching courses and providing seminars in relevant academic programs;
- 1.3 Sharing of academic information/curriculum, course materials, library cooperation and suggesting improvements whenever deemed necessary;
- 1.4 Share and exchange educational, scientific, and methodological literature/publications;
- 1.5 Mutual recognition for professional qualifications, including credit transfer;
- 1.6 Collaboration on staff training and development programs; and
- 1.7 Facilitating development projects through the involvement of experienced faculty and staff members.

2.0 Terms of any of the stipulated activities for implementation, which will be consequential to this Memorandum of Understanding, will be negotiated and established in the form of a contract. The Contract is required to be signed by both universities with the consideration of mutual benefits.

3.0 This Agreement is valid for five years from the signature date of the representatives of both universities below. This Agreement may be renewed after being reviewed and renegotiated by both parties.

4.0 Funding for activities under this Mutual Agreement may originate from the agreement between the universities and/or other legitimate funding sources.

6.0 Either of the collaborating universities have the right to terminate the Memorandum of Understanding at any given time with a notice of termination upon six months.

7.0 This Memorandum of Understanding will become effective upon signing of this agreement by the representatives from both the universities.
